

Media Access Conditions and Acknowledgement

1. I am attending as an independent freelance photographer. I am not an employee, contractor, agent, or official representative of the Organiser unless separately appointed in writing.
2. Any photography services I offer or sell are arranged directly between me and my client. The Organiser is not responsible for my bookings, payments, refunds, delivery timelines, editing disputes, or any other client-related matter.
3. My access to the event is subject to approval by the Organiser and may be restricted, limited, or revoked at any time for safety, operational, safeguarding, reputational, or conduct reasons.
4. I will follow all instructions given by the Organiser, Meet Director, event officials, venue staff, and authorised personnel.
5. I will only operate in approved areas and will not enter restricted areas unless expressly authorised.
6. I will not obstruct or interfere with athletes, referees, spotters/loaders, volunteers, announcers, livestream crew, spectators, or event operations.
7. I will prioritise safety at all times, including keeping clear of loaded barbells and walkways, and ensuring my equipment does not create any hazard.
8. I will not use flash during competition lifts unless expressly approved by the Organiser.
9. I will behave professionally and respectfully at all times, and I will not act in any way that is disruptive, offensive, intrusive, or inappropriate.
10. I will treat all athletes and participants with dignity and respect, and I will not take or publish images that are intrusive, compromising, humiliating, misleading, or inappropriate.
11. I will not enter changing rooms, toilets, treatment areas, or any other private or restricted spaces.
12. Where minors are involved, I will exercise additional care and comply with any safeguarding requirements or directions given by the Organiser.
13. I will not represent myself as the official event photographer unless expressly authorised in writing.
14. I understand that events may be live-streamed and that livestream equipments will have priority in having clear and unobstructed angles. I will endeavour to not block or otherwise disrupt livestream cameras or recording equipment.
15. I will be respectful of other media professionals in the event and will not be intentionally disruptive to their work during the event.
16. I am responsible for my own equipment, conduct, and any loss, damage, or injury caused by my negligence or breach of these conditions.

17. The Organiser is not responsible for any loss or damage to my equipment, or for any commercial dispute between me and my clients.

18. I understand that failure to comply with these conditions may result in my access being restricted or revoked, and may affect future approval to photograph at organiser-run events.

19. I agree to provide photography services in a professional manner consistent with the standard reasonably expected of a paid freelance photographer, including competent image capture, appropriate editing, clear communication, and delivery of the agreed output within the timeline promised to my client.

20. I understand that if the Organiser receives credible complaints of serious or repeated service failures, including failure to deliver paid work, materially poor quality work, misleading representations, or unprofessional conduct, the Organiser may restrict or decline my access to future events.
